

1. Candidates must be Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates already serving in Govt. Department should submit their application through proper channel.
3. Candidates must have passed class VIII.
4. Candidates must not be less than 18 years of age or more than 42 years in case of General candidates, 45 years for OBC/MOBC and 47 years for SC/ST as on 31<sup>st</sup> March, 2019.
5. The application with self attested copies of all testimonials regarding Educational Qualification, Age, Caste, along with three(3) copies of recent passport size photographs, duly signed by the candidate on the reverse side should reach the office of the undersigned.

13. Application received late or without proper supporting documents or unsigned or without photographs or incomplete Application Form will be summarily rejected.


